GIFT AID

If you are a taxpayer, and if you regularly support charities, you may well be aware of GIFT AID – a scheme brought in under new legislation in April 2000 which allows tax to be claimed back by the charity on any donation you make to it. As Group 64 is a charity (of which Group 64 Youth theatre and PTC are subdivisions) we can qualify to register under this initiative, and this enables us to make your money go further. It is similar to a deed of covenant, but with simpler administration.

Through GIFT AID, your individual membership subscription and any contributions to Group 64 (other than for tickets or classes) can be considered for a refund, enabling us not only to receive your subscription but also to receive the benefit of an additional amount via the tax we can claim back. For example, individual full membership costs £40. If we claim back the tax, it is worth £47.46 to us. This is a considerable increase to us at no extra cost to you.
